Menu Selection: Menu selection shall be arranged with N.C.C. at least (72) hours in advance of the event.

Final Guarantee Due Date: A minimum guaranteed count is due (72) hours in advance.

Food and Beverage: Due to insurance and health code regulations, all food and beverage must be provided by N.C.C. and is not allowed to be removed from the premises. In accordance with Massachusetts state law, alcoholic beverages may not be brought in or removed from the premises. N.C.C. reserves the right to refuse alcohol service to anyone at anytime. We reserve the right to discontinue bar service for any reason. Proper identification is required by all guests.

Special Menus: Any food allergies or dietary restrictions must be communicated at least 24 hours prior to the event.
